The Trinity Institute is a non-profit residential study/retreat center in Tehuacana, Texas, established to defend historic orthodox Christian truth in love. It has become a community of people that seek to provide a place where persons can find, in retreat, rest and peace in Christ and have the opportunity and space through conferences, seminars and personal studies to think reflectively about the implications of the Christian faith in every area of reality.



The Jackie Levingston Girls' Retreat will be held at the Trinity Institute in Tehuacana, Texas. The Girls' Retreat begins on Monday August 1, 2016 at 10 a.m. and ends on Thursday August 4, 2016 at 11 a.m. Participants will participate in seminars, volleyball, swimming, and a religious program. They will receive lecturers and information on preparing for careers, peer pressure, and preparing for their futures. Each participant will receive a Retreat T-Shirt and souvenirs from their activities. They will have an opportunity to swim, play volleyball, go on nature walks, and meet new friends. Registration fee for each participant is \$100.00. The fee covers housing, food, and activities for the Retreat. The Retreat is limited to thirty (30) girls. The deadline for registration is June 19, 2016. The amount after the deadline is \$125. ## **Rules for Participants**

1. Participant must be a female resident of Texas.
2. Participant must be between the ages of nine (9) and eighteen (18) before the start of the Retreat.
3. Participant must have a school grade average of a C, 2.0, or equivalent.
4. Participant must submit a liability release form signed by a parent or guardian by August 1, 2016.
5. Anyone with a Felony record cannot attend the Retreat.
6. Participants must have good moral character.
7. Participants must follow all rules and regulations set by the Retreat staff. The Retreat Staff will ensure that all rules are enforced. Failure to follow Retreat rules will result in the participant being sent home.
8. It is the responsibility of the sponsors or parents to provide transportation for participants to and from the Retreat.
9. Participants will furnish their own personal items (toothpaste, toothbrush, soap, linen, towels, etc.).

## **Parents/Guardian Responsibility**

**The Parent/Guardian of a participant in the Jackie Levingston Girls' Retreat is required to complete the following Applications prior to admittance.**

1. Youth Application
2. Participant's Health Examination Form
3. General Information Form
4. Release of Liability Form
5. Consent for Medication Form

**The Parent/Guardian is responsible for ensuring that each participant brings the following items to the Retreat:**

1. Required Medication
2. Toothpaste/brush, towels, linen, pillow, etc.
3. Spending money not to exceed \$20.00
4. Adequate clothing for three (3) days

**Participants at the Retreat will not be permitted to wear excessive jewelry.**

## **Policies and Procedures**

### **Rules and Guidelines**

1. Each participant must obey the rules and guidelines established by the Retreat Director and staff.
2. Each participant must obey the rules and regulations of the Trinity Institute.
3. Participants will be grouped and housed according to their ages (9-13 & 14-18).
4. Failure to adhere to the established rules and regulations may bring cause for dismissal from the Retreat.

### **Telephone Usage**

The phone number for Trinity Institute is (254) 395-4444. Parents keep the above number in the event of an emergency. No cellular telephones or beepers will be allowed.

### **Food and Drinks**

Each participant will receive three balanced meals per day. No food or drink will be allowed in sleeping areas.

### **Prohibited Items**

Alcoholic beverages and illegal drugs are not permitted at the retreat by participants. All firearms, fireworks, and the use of tobacco in any form are prohibited. No animals will be allowed at the Retreat.

### **Swimming Pool Rules**

1. No swimming without lifeguards present in the pool area.
2. No running! No tag! No pushing others!
3. No horse play! No throwing others into pool! No diving!
4. No food or drink! No glass containers!
5. No hanging on water volleyball net.

Any person having a skin disease, open sores, inflamed eyes, nasal infections or any communicable disease will not be permitted to use the swimming pool. Girls must wear swim suit. Lifeguards will monitor all swimming events and enforce the pool rules.
